

Grange Company of Target Archers Inc. t/a Samford Valley Target Archers President's Report – AGM 21 October 2023

Our Journey to Date

The club was established 1947 in Brisbane; offered a field at Samford towards the end of 2005, and build the first indoor hall during 2008, and relocated to Samford on Australia Day 26 January 2009. Over this period, we have gained over \$1.15M in grants and investment. The club has two indoor halls that can be joined in the future, a storage shed, 150m of shades (with only a 20 m missing link), and three outdoor ranges. It has been reported to us that the club has the best target archery facilities in Australia, and that our field is in the top four in the world for ambience.

The club holds a ten-year lease with the Moreton Bay Regional Council which is up for renewal in January 2026. We have maintained very good relationships with the local council and continue to receive great support. The club is seen as a responsible club, well governed with sound strategic plans, and one providing significant community benefit - an alternative sport and recreational activity that is "something a bit different".

We are a club for everyone; for those seeking social and recreational archery, to competitive archery, and to high performance and Olympic/Paralympic aspirants – "a sport of all".

The club has a family friendly environment, and we hold Level 3 Good Sports Club certification. The Committee encourages all members to foster the Good Sports aims, healthy eating and active lifestyles.

The club is proud of our archers and officials competing or officiating at the highest levels at international tournaments.

Our Status

Our membership is over 200 and growing each year.

Our financial management is sound.

The club has a low fee structure when compared with other large clubs. We have a reserve sinking fund for large future liabilities, so we can fund a contribution for major projects in the future like the joining of the indoor sheds into an integrated facility and as a fighting fund.

Our Beginner Courses are very important as one of the cornerstones of our financial and membership stability. Membership and participation fees are important, but we have tried to diversify our income dependency with canteen sales, grants, and the small but steady cash flow from the container recycling scheme.

Nationals

Following the success of the Nationals in 2022, the club in concert with South Queensland Archery Society hosted the National Target Championships 2023. This was the biggest Nationals ever held with about 280 individuals entered; and has been reported as the best ever. The entire field was used with 54 targets in play.

Samford Valley Target Archers history with hosting National events is,

- Australian Open in 2016
- Australian Open in 2017

- National Target Championships 2022
- National Target Championships 2023

It was a fantastic event to participate in or to proudly help deliver it, and I congratulate all medal winners and sincerely thank the crew of volunteers that “made it happen” in the lead up and during the tournament. With an estimated 2000 hours of volunteer time contributed, this value is in excess of \$40,000 in time contributed by club members.

Olympics

Brisbane is to host the 2032 Olympic Games. No details on the venue has been released. However we are working with council about the possibility of the club being part of the 2032 Olympics, perhaps not for the finals which are required to be at an iconic venue like Southbank, but either as a qualification round venue or for a venue for overseas teams at which to prepare in the lead up.

And World Archery are attempting to get compounds into the Olympic Games, the Los Angeles 2028 Olympics, as an indoor competition.

Tournaments

In addition to the club weekly rounds and club tournaments, like the Monthly Club Tournament, the club hosts Target QREs and Indoor QREs and many SQAS Championships. Next year we will host;

- 3 target QREs
- 10 indoor QREs
- SQAS Short Range Championships
- SQAS Target Championships
- SQAS Selection Event - WA Star/WA900 tournament
- SQAS Matchplay Championships

Major Equipment

The club undertook a major purchased of a ride-on line marking machine. This has made marking the field quicker and easier for the volunteers.

And the target towing device was a real success. A big thank you to everyone involved in concept and prototype development, and manufacture.

Projects

2022 saw the completion of,

- installation of subsurface drainage to the Mid Field and West Field and some levelling with the works – the effectiveness of the subsurface drainage is very pleasing
- extending the pipe to fill in the drain near the “bridge”

in 2023 the club has been very successful with a large grant for,

- additional shades, surfacing and accessible pathways

These improvement projects follow the club’s strategic plan.

A future project subject to funding includes,

- the joining of the indoor sheds – and we are working actively with Council to bring this about

Other concepts being investigated include the,

- Airconditioning of the East Indoor Hall
- Additional Solar panels

Schools Program

In 2023 the club ran a 10 week school program with 20 students from Samford State School with great success, and the clubs hopes to run the program again in 2024.

Y42032

SQAS participated in a Queensland Academy of Sport initiative to increase the local talent pool for the Olympics in 2032. The first intake of young people wishing to try a “career” in archery to the Olympics was in 2022 and a second in 2023. The club participates in this Y42032 program with Amanda Ament playing a lead role.

The club is well serviced by qualified coaches. Darren Brack the Club Coach can usually be found at the club on Saturday mornings helping archers. And he is always on the lookout for people interested to become L1 coaches to help the club with delivery of our Beginner Courses.

I sincerely thank all those coaches that help the club.

Officiating

Our judges continue to play a very important role at the club and at RGB level, nationally and internationally. Thank you, without you we could not host events.



Note 1: Summary of Significant Accounting Policies

All property plant and equipment, except freehold land and buildings, are initially measured at cost and depreciated over their useful lives to the association.

(d) Goods and Services Tax (GST)

The organisation is registered for GST.



Scope

My audit has been conducted in accordance with Australian Auditing Standards. My procedures included examination, on a test basis, of evidence supporting the amounts and other disclosures in the financial statements, and significant accounting estimates. These procedures have been undertaken to form an opinion whether, in all material respects, the financial statements are presented fairly in accordance with the accounting policies described in Note 1 to the financial statements. These policies do not require the application of all Australian Accounting Standards and other mandatory professional reporting requirements (Urgent Issues Group Consensus Views).

Qualification

As is common for organisations of this type, it is not practicable for the Grange Company of Target Archers Inc to maintain an effective system of internal control over donations, subscriptions and other fund raising activities until their entry in the accounting records. Accordingly, my audit in relation to fund raising was limited to amounts recorded.

Mortgages, Charges, and Securities

There is no evidence of any charge over the assets of the Grange Company of Target Archers Inc.

Publicity Officer's Report to AGM 2023.

Counting the publicity year from the day after last year's AGM, to today's AGM, this will bring the 2022, and the 2023 National Target Championships into the picture.

The 2022 event had quite a lot of material sent out to print, radio and television addresses. The general response was absent though the local print response was good.

In terms of graphics, the Club Gallery had 2970 photos over the period, which attracted 5088 views, so somebody looked besides me. I have no information about the audience numbers for the TV streaming of the final medals day on 7 Plus.

This year's target championships were also the subject of quite a lot of photos. The ones on the Club's gallery were taken by me. At the time of writing, in the various albums, there were 1148 photos and 26 short videos, which had had a total of 5982 views (again, not all by me) so it seems that quite a few people know about us.

The longer videos of various competitions which I placed on Facebook this year were probably not a great idea.

In terms of media interest/support throughout the year I can say that the Village Pump, edited by MaryAnne Morgan is very helpful and supportive. Nick Crockford of the Moreton Daily will also respond if his interest is piqued. His interview with Janelle Colquhoun in the Moreton Daily in August was a case in point. Again, attempts to interest other TV and radio sources came to nothing.

On Saturday 30th September I spoke briefly about the championship tournament on the morning programme of the ABC. Whether this resulted in any spectator interest I have no way of knowing.

Other articles were a "Post Nationals" report in the Village pump in October '22, about the Silver Arrow competition in the VP in February, about Taymon Kenton-Smith at the Para and VI championships in the VP in March, about the Samford State School's course in the VP in May, the You for 2032 programme in the Moreton Daily in March, an article in the Moreton Daily about the Nationals in the Moreton daily in August.

It also appears that the Club is generating more interest in our activities from the Moreton City Council and some State Government departments. This would seem to be a major purpose of publicity in the years up to the Olympics.

SVTA AGM Coaches report 2023

It's been a very busy year on the archery calendar. Personally, since the last AGM I have been part of Oceania in Adelaide, World Youths in Limerick Ireland and the World Championships in Berlin. Throw in some AA Coaching workshops, the RDP program and of course our amazing nationals my feet have hardly touched the ground. The experience gained at these events has been invaluable.

Beginners Courses.

We have run 9 beginners' courses since October 2022 with almost 200 participants. Demand is still high though some courses haven't been at capacity as they were last year. We suspect this may be due to cost of living pressures though courses are still up around the 18 to 20 participants and are our major source of new members into the club.

A quick look at the data shows us around 103 new members via the inductions.

A big thank you to all the coaches involved in the beginners' courses and inductions. Your time is valuable, and we really appreciate the effort you put in. There are a few coaches who are always ready to jump in and pick up an extra course at short notice when needed so a special thanks to those, I won't name them for fear of missing someone, but you all know who you are so thanks, it's very much appreciated as many hands make light work.

Ozbow

This continues to be the focus of our coaching for newer archers and occurs on Saturday mornings on the mid field. There is normally a coach rostered on here as well as the Ozbow coordinator Colin so thanks to those who give their time up here on a regular basis as well.

Workshops

We have not done any specific workshops this year tried to run these in the past and attendance has been hit and miss. Earlier this year Evan ran a fletching workshop and only had around 4 attendees. Amanda and Matt ran a barebow day last November and it was very well attended and everyone had a fun day learning the art of barebow.

General Coaching

While this normally happens on the mid field on a Saturday morning we have also continued on with an individual approach this year and I have done a few one-on-one sessions with archers who have requested some coaching.

In conjunction with the Regional Development Program we also had a session on match play that was opened up to all archers and a few SVTA members joined in there. I think everyone who attended really gained something from that session.

Again, we tried very hard to get a youth initiative running off the back of the You_4_32 program. Myself and Amanda put a fair bit of time in to developing a program and we had a number of youth archers and their parents express interest initially but attendance was lacking and waned

fairly quickly. What has resulted out of this though is a few archers from other clubs becoming associate members and regularly coming to SVTA for coaching with their personal coaches.

If any archer, regardless of their current ability desires more coaching, either on an adhoc basis or establishing a personal coach relationship with one of our coaches please feel free to see me for a chat.

Coaches Development

Active coach numbers are

- 1 x Level 3
- 3 x Level 2 Presenter/Assessors
- 6 x Level 2
- 12 x Level 1

We also have a Level 1 coach who is doing the Level 2 course in November.

Equipment

We continue to have good levels of equipment for the beginners classes and new members to hire including 3 compound bows that can be used on a trial basis with a coach present. A big positive was the addition of new finger tabs for the beginners' classes. So instead of the beat up worn-out ill-fitting Cartel tabs I developed a low cost 3D printed tab with a finger spacer that is working very well. We even still have most of them.

Regional Development Program

We have hosted a number of RDP days here and have coaches and archers actively involved in this space. If you are a competitive archer and are interested in seeing if you qualify for this program for next year, please see me. SVTA has a number of archers and coaches that participate in this program. As the SQAS RDP program coordinator I'd like to take this opportunity to thank the SVTA committee and members for making the clubs facilities available to the program.

International Representation


We have had 4 archers represent Australia at international level this year




