General business

Lease renewal meetings have been held with MBCC. They are very happy with the club, what we have developed together, with the way we work with the community and how stable the management committee is. MBCC are preparing a 10 year renewal to our lease, which is a fantastic outcome, will be sending SVTA a draft shortly.

Para National sponsorship meeting was held on site. Application will be sent to us to fill out in due course. It is noted however that AA has not yet confirmed that the event will be held at SVTA. Have not yet heard anything about the funding for construction of the shed joining project, however the design is almost at 100% and is truly shovel ready to go to tender.

The Club Coach is considering how to encourage technical development of new club members to sustain their skills acquisition and continued interest, with a few initiatives being developed for trial.
